To all Non-Resident Students :

According to the law of Macau, if Non-Resident students at Macau University of Science and Technology, finishing studies early, fail to complete a degree and so on, they should apply for ordinary "Authorization to Stay" and apply for ordinary "Authorization to Stay" from Macau.

A notification will be sent to the Non-residents Students are no longer students of Macau University of Science and Technology and their "Special Authorization to Stay" will be terminated. Students should leave Macau on or before the completion and approval of the school leaving procedure. If students transfer to the other university after completing a degree, they should apply for ordinary "Authorization to Stay" at the Foreigners Subdivision before the expiry of the ordinary "Authorization to Stay".

If students do not apply for "Authorization to Stay" before the expiry of the original "Special Authorization to Stay", they will become "overstay" and will be fined according to the law of Macau. If students do not apply for "Authorization to Stay" before the expiry of the original "Special Authorization to Stay", they will become "overstay" and will be fined according to the law of Macau.

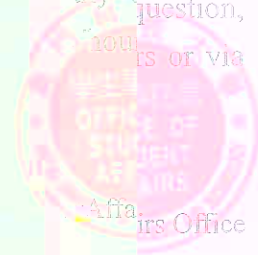
